But that's most likely an unusual situation. Not a normal situation. Be sure to get legal counsel before you and your kids leave the state your abuser is in. Find out what the laws are in that state. Don't leave your state until you talk to legal aid or a lawyer. I got really good free counsel from a lawyer in Texas. Which is rare. Then my daughter and I left for Iowa. I got to divorce in Iowa in 2015. My ex was still in Texas then. It was a miracle that all of this worked for me. Again, it's rare to have this kind of situation work in a positive way.
