Bailey, if the case is still open the agency would be responsible and the person of contact would be the caseworker. If the case is open and court involved, then the case plan becomes a court-ordered document which can be enforced by the courts. If the case is closed, there is unfortunately no way of ensuring the recommendations are followed through.

I watched cps ignore all these protective factors caseworkers are supposed to focus. I am stumped. strangers and mandatory reporters are calling cps and now they won't even respond. three calls now.

I am not the only one. Many protective mothers are facing this in Texas.

All CPS has done is emboldened him and my daughter is losing hope. it adds to this new behavior of "I don't care" and "it doesn't matter."

I'm very sorry to hear this. There are many flaws in the system and so much depends on the worker taking the calls and the workers assigned to the case. (Hannah)

2nd CPS case-opened in June, still open. emergency custody denied. 2 of 3 of my kids reported playing and accessing with firearms- reported to the therapist and me- investigated a few times, this worker seems to get it but i haven't heard from her in months now so who knows. he denies it and relocated firearms out of his house. no services suggested at this point
